RESOLUTION 2008- 01

RESOLUTION AUTHORIZING AND DIRECTING THE VILLAGE MANAGER TO
PREPARE SPECIFICATIONS, AND TO ADVERTISE FOR BIDS, FOR THE
VILLAGE'S 2008 ROAD IMPROVEMENT PROGRAM

WHEREAS, Village Council's Street, Public Utilities and Sewers Committee having reported and recommended to Council the implementation of a specific, detailed street improvement program for 2008, and

WHEREAS, Council having accepted and approved said Committee's report and recommendations, and

WHEREAS, Council desiring to ascertain the cost for the street improvement program before contracting for said work,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF AMBERLEY VILLAGE, STATE OF OHIO, seven (7) members elected thereto concurring:

SECTION 1: The Village Manager, with engineering support, shall prepare specifications for, and the Village Manager shall advertise for bids for, the furnishing of labor and materials for:

Program I: Arborcrest Drive, Hudson Parkway [Ridge to Farmcrest], Larkfield Drive (mill and pave), Kincaid Road [top of the hill to Farmcrest], Oakridge Drive [near Fair Oaks], East Winding Way (mill and patch), Larkfield Drive, Jeffy Hill [concrete gutter], Longmeadow Lane, Springvalley Drive [North of Galbraith], Lamarque Drive [North of Whiteree to Longmeadow] (curb program).

Program II: Lynnehaven Drive (mill and pave), Belkay Lane (micro surface), Sorrento [GCWW trench lane only], Lynnehaven Court [GCWW trench and cul-de-sac only], Section Road [several locations], Galbraith Road [includes some base repair], East Farm Acres, Fair Oaks Lane [patch and widen] (mill and patch), Beechlands [subdivision], Laurel Oak Lane (curb program).

SECTION 2: The Village Manager is authorized and directed to advertise in a newspaper of general circulation in the Village for proposals to complete the 2008 street improvement program.

SECTION 3: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
