ORDINANCE NO. 2012-04

ORDINANCE ESTABLISHING PARKING PERMIT FOR  
AMBERLEY GREEN FOR 2012-2013

WHEREAS, Amberley Village provides the use of Amberley Green to enhance recreational opportunities and to promote the health and welfare of the community;

WHEREAS, in order to maximize the use of the Amberley Green as well as control and manage use of the parking lot at Amberley Green, the Council desires to establish a parking permit for 2012-2013;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF AMBERLEY VILLAGE, STATE OF OHIO, six (6) members elected thereto concurring:

**SECTION 1:** Section 76.05(B) of the Municipal Code of Ordinances is amended to read as follows:

(B) (1) No person shall stand, or park a vehicle, on village property where a permit is required as posted unless said vehicle displays an Amberley Village Vehicle Identification Sticker or other designated parking permit authorized by Village Council.

(2) Parking permits are required for the Amberley Green parking lot located at 7801 Ridge Road. Such permits will be valid from the effective date of this ordinance through December 31, 2013. Applicants must provide the Village with a valid name, current address, phone number, and email address before a permit or sticker will be issued. The replacement fee for a lost or damaged permit or sticker is \$10.00. The Village Manager may revoke the privileges granted herein at any time for a violation of any Village rule, policy, or procedure relating to use of Amberley Green.

**SECTION 2:** Council directs the Manager to make a reasonable effort to notify nonresidents of the opportunity to obtain a parking permit.

**SECTION 3:** Council directs the Public Building and Parks Committee to review this program in 2013 to determine if changes are necessary for future years.

**SECTION 4:** This Ordinance is declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of the Village. The reason for the said emergency is to implement the new permit system during the 2012 summer season.
