RESOLUTION NO. 2013-05

RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO
AWARD MT. PLEASANT BLACKTOPPING CO. INC. THE CONTRACT FOR THE
AMBERLEY VILLAGE 2013 ROAD PROGRAM

WHEREAS, the Village Manager was authorized and directed to advertise for bids for road repair and resurfacing pursuant to the Amberley Village 2013 Road Program, and bids were received and considered, and

WHEREAS, the Streets, Public Utilities and Sewers Committee and Village Engineer reviewed the bids and recommends that the Village pursue the scope of work included in the Base Bid and Bid Alternates No. 1 and 2;

WHEREAS, Based on the chosen scope of work, the Streets, Public Utilities and Sewers Committee recommends that Council award the contract to the lowest responsible bidder, Mt. Pleasant Blacktopping Co. Inc.;

WHEREAS, funding for the 2013 Road Program comes from the #200 Street Fund for road-related scope of work, and from #600 Storm Water Fund for storm water-related scope of work, which funds have already been budgeted and appropriated;

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF AMBERLEY VILLAGE, STATE OF OHIO, seven (7) members elected thereto concurring,

SECTION 1: That the bid of Mt. Pleasant Blacktopping Co. Inc., received in response to the public advertisements requesting proposals for furnishing labor and materials for the Amberley Village 2013 Road Program, for a total bid of \$245,140, which includes an amount for the Base Bid of \$202,355 plus an amount for Bid Alternate No. 1 for Kentland Court of \$16,260 and Bid Alternate No. 2 for Patrisal Court of \$26,525, being in accordance with the Village's specifications, and being the best total bid, is hereby accepted.

SECTION 2: The Village Manager is hereby authorized and directed to enter into a contract on behalf of the Village for the performance of said work by Mt. Pleasant Blacktopping Co. Inc.

SECTION 3: That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
